

Regulations for the « Christmas with Ariane » competition

Under the terms of these rules and regulations, the « Organizer » designates ArianeGroup SAS, a company with a capital of 265 904 408,00 euros, register No. 519 032 247 in the commercial register of Nanterre, whose headquarters is at 7 Quai André Citroën, 75015 Paris, and is represented by Alain Charmeau.

The Organizer is organizing a free competition for which no purchase is necessary called “Christmas with Ariane” on Facebook and Twitter between Monday December 25 at 5.05 PM CET and Wednesday December 27 at 5 PM.

Article 1 – Conditions for participation

Participants in the competition (hereinafter designated the « Participants ») may take part in the competition provided they respect the conditions and instructions without reserve or restriction.

The competition is open to any person who:

- Is over the age of 13
- Has an internet connection, a Facebook or Twitter account

Participation by minors is under the responsibility and authorization of a legal representative who can justify his or her parental authority.

The personnel of the Organizer or any affiliated company, as well as members of their immediate families (including spouses, parents, children, brothers and sisters) and more generally anyone having been involved directly or indirectly in preparing this competition are excluded from participating in it.

Participants who take part in the competition and who fulfill the above conditions will be contacted by the Organizer if they win. They must then supply their full contact details. These details will comprise their forename, surname, email address, and physical address with postcode and town. These details are obligatory to validate the inscription of the Participant. A participant who wins the competition but fails to provide his or her contact details will be disqualified and will not receive a prize.

Article 2 – Participation period

The competition will be open from Monday December 25 at 5.05 PM CET and Wednesday December 27 at 5 PM.

Article 3 – How to participate

To take part in the « Ariane for Christmas » competition, all you have to do is:

1. Access the ARIANE Facebook page <https://www.facebook.com/ArianeGroup/> or the Twitter account <https://twitter.com/ArianeGroup> between Monday December 25 at 5.05 PM CET and Wednesday December 27 at 5 PM CET.
2. Put an answer to the question in the comment box, giving an answer as near as possible to the correct one.
3. The five Participants on each social media who give the closest answer to the correct one will win some ArianeGroup goodies.

Participation is strictly personal. Participants can in no instance take part using several pseudonyms or on behalf of other participants. If multiple participations are observed, they will be nullified.

The competition is limited to one prize per household (same name and/or address or email address).

Article 4 - Prizes

Five different types of prizes will be offered as prizes throughout the duration of the competition. Each winner will receive a prize. Prizes will increase in value according to how close the response is to the correct answer.

Values of prizes:

- Prize 1: 50€
- Prize 2: 35€
- Prize 3: 20€
- Prize 4: 15€
- Prize 5: 10€

Article 5 – Selection of winners

The five winners on each social media will be selected by hand, according to their answer. Winners will be notified within a week from the selection date. They will each receive a private message from the ArianeGroup Facebook page or the ArianeGroup Twitter account.

Any incomplete or incorrect contact details will make participation in the contest null and void and a winner in this situation will forfeit his or her rights to a prize. The prize which would have been awarded in such an instance will be withdrawn from the contest. Participants authorize the Organizer to check their identity and address, although it will not carry out a systematic verification of the contact details of all Participants. Participations submitted by post will not be taken into account.

Article 6 - Distribution of prizes

The prizes described above will not be taken back, or exchanged for other objects or services whatever their value, and will not be the object of a financial transaction of any type in cash, by cheque, bank transfer or other means. The Organizer will not accept any request for modifications (date, location, prize...) for whatever reason.

If the Participant cannot or chooses not to take delivery of a prize, he/she will not be entitled to any compensation. In case a prize is not available, the Organizer reserves the right to substitute the prizes with products or services of an equivalent or higher value, and will not accept any claims in this regard.

However, if the prizes cannot be delivered by the Organizer for reasons beyond its control, or if a supplier cannot provide them. Participants cannot claim compensation or a financial payment of equivalent value.

The Organizer will provide no service or guarantee; winners will only receive the prizes planned for distribution. Costs for transportation, accommodation, food, insurance, personal expenses etc. not specifically included in the prizes are the sole responsibility of the Participants in the event that the winner travels to pick up his or her prize.

The “On prend un café” agency will ship packages with prizes to winners through the postal service one (1) to three (3) weeks after the winning submissions have been decided. The prizes will be sent to the address that winners give to the Organizer by private message on Facebook or on Twitter.

In the event that a prize cannot be shipped by post, information about how to pick up the prize will be given in the email that the winner will receive confirming his/her win.

After a winner takes possession of a prize, he/she will be solely and exclusively responsible for its use. The Organizer declines all responsibility regarding any use of a prize that doesn't conform to normal usage, or that doesn't conform to current legal or administrative regulations.

Article 7 - Obtaining the rules & regulations

The rules of the competition are available and can be consulted in the post about the competition on the Ariane Facebook page and the Ariane Twitter profile.

Article 8 - Limits of responsibility

Participation in the competition implies a knowledge and acceptance of the characteristics and limits of the Internet, notably concerning technical performance, the time necessary to consult, search or transfer data, the risks of disconnection, the risks linked to connection, the absence or protection of certain data from possible hacking, and the risks of possible contamination from viruses present on the Internet.

The Organizer cannot be held responsible for any malfunctions of the Internet, for any configuration issues, or for problems related to a specific Internet browser.

The Organizer will not guarantee that its Internet site and/or the competition will function without interruption, that is not affected by data processing errors, or that such errors will be corrected. The Organizer cannot be held responsible in the event of a technical dysfunction of the competition, if players are unable to connect to the Internet site or participate, if a player's details aren't received for whatever reason for which it cannot be held responsible (for example, if the player is using computer equipment or a software environment that is insufficient for his/her inscription), or in the case of problems with email distribution. The players cannot claim any damages for these reasons. The Organizer will not, for the same reasons, be held responsible for any damage, either material or immaterial, suffered by the players, by their computer equipment or the data contained on it, or any direct or indirect consequence that may result, notably regarding their personal, professional or commercial activity.

Article 9 - Acceptance of the regulations

Participation in the competition implies the full and unconditional acceptance, without reserve, of these regulations. Any person contravening one or several articles of these regulations will forfeit the right to participate in the competition, as well as to any prize that he/she could have won.
